



## **Polisi Codi Tâl Ysgol Gymraeg Gwaun y Nant**

Mae addysg yn ystod oriau ysgol yn rhad ac am ddim. Nid ydym yn codi tâl am unrhyw weithgarwch a wneir fel rhan o'r Cwricwlwm Cenedlaethol ag eithrio gwersi cerddoriaeth unigol neu grwp.

Pan fydd y plant yn mynd ar wibdeithiau ac ymweliadau addysgol, gofynnwn i'r rhieni gyfrannu yn wirfoddol tuag at y gôst. Os nad ydym yn derbyn arian gan rai teuluoedd, nid ydym yn atal y plant rhag cymryd rhan yn y weithgaredd. Mewn achosion o'r fath byddem yn gofyn i'r rhieni hysbysu'r ysgol ar y cyfle cynharaf posibl er mwyn rhoi amser i chwilio am gyllid o ffynhonnell arall. Weithiau mae'r ysgol yn talu costau ychwanegol er mwyn cefnogi'r ymweliad. Os nad ydy hyn yn bosibl, yna bydd rhaid ystyried atal y gweithgaredd. Mater i'r Pennaeth yw'r holl benderfyniadau uchod.

Byddwn yn hysbysu'r rhieni ar y cyfle cynharaf posibl ynghylch gweithgareddau lle mae cyfraniadau gwirfoddol yn angenrheidiol

Pan mae'r ysgol yn trefnu ymweliad preswyl sydd yn rhan o waith y Cwricwlwm Cenedlaethol, rhaid i ni godi tâl am y llety, bwyd a'r teithio. Mae'r rhieni sydd yn derbyn budd-dal gan y wlad neu ag efeilliaid yn yr un flwyddyn yn cael cynnig gostyngiad.

Fel rheol mae ffyrdd o rannu taliadau dros gyfnod o amser - gall y rhai sydd eisiau gwneud hynny gysylltu â swyddfa'r ysgol

Yn ystod eu cyfnod yng Nghyfnod Allweddol 2, bydd y disgyblion yn cael gwersi nofio. Caiff rhain eu cynnal yn ystod oriau ysgol fel rhan o'r Cwricwlwm Cenedlaethol. Ni ofynnir am dâl am y gwersi yma. Rhaid cael caniatad ysgrifenedig gan y rhieni cyn bod y plant yn gallu derbyn y gwersi.

O dro i dro gellir cynnal cyngherddau gydag elfen o godi arian ynghlwm wrthynt. Mater i'r Pennaeth yw penderfynu a ddylid codi tâl am ddigwyddiad o'r fath.

## **Ysgol Gwaun y Nant Charging Policy**

All education during school hours is free. We do not charge for any activity undertaken as part of the National Curriculum with the exception of individual or group music tuition.

When organising school trips or visits which enrich the curriculum and educational experience of the children, the school invites parents to contribute to the cost of the trip. All contributions are voluntary. If we do not receive sufficient voluntary contributions, we may cancel a trip. If a trip goes ahead, it may include children whose parents have not paid any contribution. We do not treat these children differently from any others.

If a parent wishes their child to take part in a school trip or event, but is unwilling or unable to make a voluntary contribution, we do allow the child to participate fully in the trip or activity (with the exception of residential activities). In such cases we would ask parents to inform the school at the earliest opportunity so as to allow time to attempt to access alternative funding. Sometimes the school pays additional costs in order to support the visit. Additionally, there may be extra fund raising activities or the PTA may be approached for funding. All the above decisions will be at the discretion of the Headteacher.

For any activity where voluntary funding will be necessary, we will inform parents at the earliest opportunity.

The school organises a residential visit in school time, or mainly school time, which is to provide education directly related to the National Curriculum. We do make a charge to cover the costs of board, lodging and travel.

There are usually ways to spread payments over a period of time – those wishing to do so are requested to contact the school office.

The school organises swimming lessons for all children at some stage during Key Stage 2. These take place in school time and are part of the National Curriculum. We make no charge for this activity. We inform parents when these lessons are to take place, and we ask parents for their written permission for their child to take part in swimming lessons.

From time to time there may be certain events that are considered to have an element of fund raising involved, such as a concert. Any charge levied for such an event would be entirely at the discretion of the Headteacher.

All decisions relating to financial help for individual pupils are at the discretion of the Headteacher.

Any reference made above to “the Headteacher” is to include the Deputy Head at such times and in such circumstances as require that person to assume the role and responsibilities of the Headteacher.
